Golfers of **all abilities** are encouraged to participate. This year's event will include an 8am shotgun start and prize holes to challenge the competitive golfers. The Women's Transportation Seminar is an international organization with a membership base of over 4,000 transportation professionals in 37 chapters in the U.S., Canada, and the United Kingdom.
